

RREF Bursary 2024/25

Information and Guidance Notes

Bursary Details

The Reading Real Estate Foundation (RREF) offers financial support to Undergraduate and Masters students based on a demonstration of financial need.

For the academic year 2024-25, the RREF BSc Bursary offers the following financial support:

- **£15,000** (£5,000 per year for three years of study) towards the cost of living.
- **£30,000** (£10,000 per year for years of study) towards the cost of living.
- **£60,000** (£20,000 per year for the three years of study) towards the cost of living and tuition fees.

To apply, please submit a single application form. Completed submissions will be reviewed for consideration for all of the mentioned amounts.

Who Can Apply

To qualify for the RREF BSc Bursary, you must hold an offer to study one of the following Undergraduate Real Estate & Planning courses:

RREF Bursaries are given on a needs basis. As such, you must also meet one or more of the following criteria:

- A low-income household
- Limited support from family
- First in the family to attend University
- Looked after by the local authority (been in care)
- Attended a non-fee paying school during secondary education
- A recipient of free school meals
- Any other hardship that has led to financial difficulty
- Applicants must demonstrate a commitment to their studies and a willingness to be a RREF Volunteer

Please note that if you detail any of the above criteria in your application, RREF may ask you to provide evidence

How to Apply

To apply, you will need complete an online application form. Please note that incomplete applications will not be considered. If any sections do not apply to you, kindly indicate this with 'n/a'.

Timeline of Application Process

On receipt of your application, you will be contacted via the email address provided to confirm that your application has been received. You will be informed of the RREF Disbursements Committee decision within 4 weeks after the deadline

All applications are reviewed individually by the RREF Disbursements Committee, who oversee the disbursement of RREF funds to support students within the Real Estate & Planning Department at Henley Business School, University of Reading. The committee consists of representatives from RREF and members of REP academic staff. Please note that all applications submitted remain strictly confidential and are only shared with the RREF Disbursements Committee.

Expectations If You Are Successful

Funds will only be awarded to Real Estate & Planning students once they have officially enrolled at Henley Business School, University of Reading. Therefore, all students must meet admission criteria to receive funds.

If you are awarded a RREF Bursary, we ask that you fulfil certain expectations aligned with the charity's objectives. These include:

- Producing a thank you letter to the donors of RREF outlining how the funding will impact you (your anonymity will be provided if requested)
- Providing regular updates to RREF on the progress of your studies when requested
- Attendance at our annual RREF Recognition Event in Spring

A Note on Deferring

This bursary is exclusively designated for recipients commencing their studies in the 2024-25 academic year. **Kindly be aware that, unless under exceptional circumstances, deferring your studies will result in the forfeiture of your bursary offer, and you will be required reapply in the following year.**
